(d) Name of Bidders whose Bids were rejected and the reasons for their rejection:

GD “Granit” AD - Skopje (Macedonia)

The amount of Bid security submitted by the Bidder is lower than the one required. Bidder has provided amount of Bid security of 2,465,000.00 MKD and the amount in the Bidding documents is 2,645,000.00 MKD or 43,000.00 EUR.

Zikol DOOEL Strumica (Macedonia)

The Bidder does not satisfy the requirement of minimum one (1) similar contract with a value of 1,455,000.00 EUR that has been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1st January 2008 and application submission deadline, 43,000 m³ earth works (excavation and embankment) and 8,000.00 t asphalt works. The bidder has not provided evidence that he has executed the quantities as the partner in the Joint Venture of the presented project.

Also the Bidder has not provided relevant documentation in English language for equipment for excavation, pavers for building in asphalt, milling equipment, mechanical broom, graders, emulsion sprayers and rollers.

N.P. Viktorija Invest International sh.p.k, Kosovo

The Bidder did not demonstrate that it has personnel for the key positions e.g. Site Manager and Asphalt/Material Engineer. For the Site Manager no diploma was provided and Asphalt/Material Engineer does not have relevant experience. The provided concrete plant is not on the territory of the Republic of Macedonia. For the proposed concrete plant, the Bidder did not provide permits for operation prescribed with the Laws of the Republic of Macedonia, and copies of such permits were not attached to the Bid. Bidder has not demonstrated access to the necessary materials for preparation of concrete, crushed stone, material for production of asphalt etc.

Summary of contract awarded:

The Works include rehabilitation of the existing asphalt carriageway of the Regional Road R2343, Delcevo – Golak with total length of 10,50km. The Works are mostly consisted of scrapping existing asphalt layers, patching of pot holes, machine cutting of longitudinal and transversal joints, filling of cracks, construction of shoulders with mechanical stabilization of crushed stone, construction of asphalt layers, works on drainage, placing new traffic signs, new road marking, new equipment, traffic regulation during execution of the Works etc.
