INVITATION FOR TENDERS

This Invitation for Tenders follows the General Procurement Notice for this project which was published on the European Bank for Reconstruction and Development (the Bank) - EBRD website: 16.02.2015.

Public enterprise for state roads hereinafter referred to as the Employer, intends using part of the proceeds of a loan from the Bank towards the cost of the above cited project.

The Employer now invites sealed tenders from contractors for the following contracts to be funded from part of the proceeds of the loan:

Lot 1 Rehabilitation of National Road A3 bypass Kocani L=6 km, generally the works consist of removing of asphalt layer, repair of edges on existing asphalt layer, repair of shoulders and gutters, repair of potholes, spraying of pavement with emulsion, applying new asphalt layer, cleaning of culverts and channels etc. This Project refers to the eastern part of the Republic of Macedonia.

Lot 2 Rehabilitation and Reconstruction of Regional road R1205, section Probistip – Krupiste L=18km, generally the works consist of improvement of road base on embankments, construction of sub-grade, construction of a blanked course of crushed stone, removing of asphalt layer, repair of edges on existing asphalt layer, repair of shoulders and gutters, repair of potholes, spraying of pavement with emulsion, applying new asphalt layer, cleaning of culverts and channels etc. This Project refers to the eastern part of the Republic of Macedonia.

Lot 3 Rehabilitation of Regional road R2133, section Kumanovo – Opaе L=6km, generally the works consist of removing of asphalt layer, repair of edges on existing asphalt layer, repair of shoulders and gutters, repair of potholes, spraying of pavement with emulsion, applying new asphalt layer, cleaning of culverts and channels etc. This Project refers to the northern part of the Republic of Macedonia.

Lot 4 Rehabilitation of Regional road R1104, section Kumanovo – Nikustak L=11km, generally the works consist of removing of asphalt layer, repair of edges on existing asphalt layer, repair of shoulders and gutters, repair of potholes, spraying of pavement with emulsion, applying new asphalt layer, cleaning of culverts and channels etc. This Project refers to the northern part of the Republic of Macedonia.

Lot 6 Rehabilitation of National Road A2, section Rankovce – Kriva Palanka L=21 km, generally the works consist of removing of asphalt layer, repair of edges on existing asphalt layer, repair of shoulders and gutters, repair of potholes, spraying of pavement with emulsion, applying new asphalt layer, cleaning of culverts and channels etc. This Project refers to the north eastern part of the Republic of Macedonia.

Lot 7 Rehabilitation of National Road A4, section Stip – Radovis L=21 km, generally the works consist of removing of asphalt layer, repair of edges on existing asphalt layer, repair of shoulders and gutters, repair of potholes, spraying of pavement with emulsion, applying new asphalt layer, cleaning of culverts and channels etc. This Project refers to the eastern part of the Republic of Macedonia.

Tenders are invited for one or more lots. Each lot must be priced separately. Tenders for more than one lot may offer discounts and such discounts will be considered in the comparison of tenders.

Tendering for contract to be financed with the proceeds of a loan from the Bank is open to firms from any country.

To be qualified for the award of a contract, tenderers must satisfy the following requirements:

General Experience: Experience under contracts in the role of contractor or management contractor for the last 5 (five) years prior to the tender submission deadline, and with activity in at least nine (9) months in each year.

Specific experience:

(a) Participation as contractor or management contractor in at least 1 (one) contracts within the last 5 (five) years, that have been successfully and substantially completed and that are similar to the proposed Works. The similarity shall be based on the physical size, complexity, methods/technology or other characteristics, each with a value of at least:

For Lot 1: EUR 1,500,000

For Lot 2: EUR 3,500,000

For Lot 3: EUR 1,000,000

For Lot 4: EUR 1,600,000

For Lot 5: EUR 2,500,000

For Lot 6: EUR 2,500,000

For Lot 7: EUR 2,500,000

(b) For the above or other contracts executed during the period stipulated in 2.4.2(a) above, a minimum experience in the following key activities:

for Lot 1: 13,000 t/year asphalt concrete production; for Lot 2: 50,000 m³/year earthworks, 26,000 t/year asphalt concrete production; for Lot 3: 10,000 t/year asphalt concrete production; for Lot 4: 14,000 t/year asphalt concrete production; for Lot 5: 40,000 t/year asphalt concrete production; for Lot 6: 26,000 t/year asphalt concrete production and for Lot 7: 33,000 t/year asphalt concrete production, or cumulative of the quantities specified for each Lot separately, for which the tenderer is submitting its tenders.

Personnel Capabilities: Project Manager which must have at least 7 years of total work experience with at least 5 years in similar works for all 7 Lots; Assistant for geotechnical works, which must have at least 5 years of total work experience with at least 3 years in similar works for Lot 2; Assistant for asphalt works, which must have at least 5 years of total work experience with at least 3 years for all 7 Lots; Short-term Environmental Expert no.1, which must have at least 5 years of total work experience with at least 3 years in similar works and only one expert can be engaged on all Lots and Surveyor, which must have at least 5 years of total work experience with at least 2 years in similar works for all 7 Lots.

Equipment Capabilities: The tenderer for Lot 1, 3, 4, 5, 6 and 7 shall own, or have assured access to (through hire, lease, purchase agreement, availability of manufacturing equipment, or other means), the following key items of equipment: (i) Concrete plant with capacity of at least 20 m³/h on the territory of the Republic of Macedonia – 1 plant for all Lots (ii) Asphalt plant with capacity of at least 80 t/h for production of asphalt, for each Lot the Tenderer must present capacity of minimum **40 t/h**, however the asphalt plant shall be with minimum capacity of **80 t/h.**, (iii) Pavers that enable execution of asphalt works on the carriageway line: with width of up to 8.0m without longitudinal connections, 6 pavers for Lot 1, 3, 4, 5, 6 and 7 or 1 paver per each Lot (iv) Milling equipment with milling width 1000 – 2000mm, 6 milling machines for Lot1, 3, 4, 5, 6 and 7 or 1 milling machine per each Lot (v) Rollers: 2 steel drum and 1 pneumatic typed, 12 steel drum rollers and 6 pneumatic typed rollers for Lot 1, 3, 4, 5, 6 and 7 or 2 steel drum roller and 1 pneumatic typed roller per each Lot (vi) Emulsion sprayer, 6 emulsion sprayers for lot 1, 3, 4, 5, 6 and 7 or 1 emulsion sprayer per each Lot.
