(d) Name of Bidders whose Bids were rejected and the reasons for their rejection:

- **JV Lendi Grup Ltd Skopje** Republic of North Macedonia and **Bojta ING Ltd Eskport-Import Skopje** Republic of North Macedonia

Reasons for rejection:

1. The amount indicated in the Bid Security in figures is 1.230.000,00 MKD, while the amount in words is: one million two hundred thousand. Because of this discrepancy between the amount presented in figures and in words, the Bid Security is not acceptable; and
2. The Bidder does not have specific experience as required under 2.4.2(a) " Participation as contractor, management contractor, or subcontractor, in at least one (1) contract for carrying out Works that includes placing asphalt, concrete kerbs, traffic signs, road markings and equipment on roads (**motorway, national or regional road**) within the last five (5) years." The Bidder hasn't participated in works on **motorway, national or regional road**.

- **JV DPSI Keding Skopje** Republic of North Macedonia and **DGK Zikol DOOEL Strumica** Republic of North Macedonia

Reasons for rejection:

1. The Project Manager does not have the relevant experience for the position and despite the requested clarification, the Bidder did not submit evidence to prove otherwise.
2. One of the partners in the JV has not submitted original financial documents and documents to prove the financial indicators required as well the documents to prove required information under 2.2 Historical Contract Non-Performance. Both sets of documents are issued by State Central Register. The Bidder hasn't provided the necessary documents required with the requested clarification.

Summary of contract awarded:

Black Spots improvement as a part of Road Safety Activities shall be executed on the eight locations of regional and national roads. The Works are mostly consisted of scrapping existing asphalt layers, construction of asphalt layers, works on drainage, placing new traffic signs, new road marking, new road equipment, slope protection, traffic regulation during execution of the Works, etc.
