Procurement Specialist

The Public enterprise for state roads has applied for financing from the World Bank toward the cost of the Euro 52 million and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) include the responsibility for coordination and management of all day-to-day procurement activities needed for project implementation, and provide on-the-job training for PMT staff.

The Consultant will be a member of the PMT and shall report to the Project Director and/or Project Manager. The Consultant shall produce Annual Working Program for each year; Procurement packages for procurement of each activity; any other report upon request with respect to the procurement activities under the Project as well as maintain records of all correspondence (Archive) in respect to the procurement issues of NRRRP project overall. The Consultant shall provide full time services for the period ending September 30, 2019. Expected start of services is October 2014.

The Public enterprise for state roads now invites eligible individual Consultants to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services (CV, description of similar assignments, experience in similar conditions, etc.).

The evaluation criteria are:

- Bachelors’ Degree in Engineering, Architecture, Law, Economics, Procurement, Supply Chain Management, or its equivalent from a recognized university.
- At least five years of practical experience in procurement management.
- Professional experience in procurement of civil works, goods, consulting services and non-consulting services under WB or any other international organizations guidelines, working experience in WB financed project or other international financed projects is required.
- Sound and good knowledge of Government procurement rules and legal requirements related to procurements in Macedonia is an advantage;
- Proven experience in managing contracts in civil works, supply of goods and consultancy services and procurement planning is an advantage.

- Full computer literacy (MS Office).
- Excellent verbal and writing skills in Macedonian and English.
- Proven teamwork skills.
- Ability to work under pressure and meet deadlines.
