TECHNICAL AND CONTRACT MONITORING SPECIALIST

The Public Enterprise for State Roads (PESR) has applied for financing from the World Bank toward the cost of the Euro 52 million and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) include the responsibility to collect data from the Project Management Team (PMT) and Public Enterprise staff relevant for monitoring of all contracts under the project, collect data on progress of all physical works, assist in preparation of quarterly disbursement plans, monitor budget of relevant contracts, provide an ‘early warning’ system that can indicate where future problems may arise and reduce any repetition of problems previously experienced, assist the PESR PMT Engineers in quality of preparation of the necessary preliminary and detailed engineering and design studies, assist the PESR PMT Engineers to ascertain the compliance of the all investment project proposals with the regulations and/or requirements of the respective ministries of the Government and ensure that all necessary permits or licenses are obtained, assist the PESR PMT Engineers in carrying out site supervision of implementation of investment projects and ensure the adequate management of contracts for works, coordinate and communicate with municipalities, ministries and other state bodies and institutions whenever necessary, keep evidence of the entire Project documentation, extract, monitor and report on procurement data for active projects.

The Consultant will be a member of the Project Management Team and shall report to the Project Director and/or Project Manager. The Consultant shall produce Annual Working Program for each year, any other report upon request with respect to the to the

program activities under the Project as well as maintain records of all correspondence (Archive) in respect to the program issues of the overall project.

The Consultant shall provide full time services for the period ending September 30, 2019. Expected start of services is September 2015.

The Public Enterprise for State Roads now invites eligible individual consultants to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services (Letter for expression of interest with description of similar assignments, CV, experience in similar conditions, etc.).

The evaluation criteria are:

- Bachelors' Degree in civil engineering or architecture.
- At least five years of practical experience in a related field of work.
- Experience in contract management is an advantage.
- Full computer literacy (MS Office).
- Excellent verbal and writing skills in Macedonian and English.
- Proven teamwork skills.
- Ability to work under pressure and meet deadlines.
