The Public Enterprise for State Roads of the Republic of North Macedonia (PESR) has received financing from the World Bank toward the cost of the Road Upgrading and Development Project (RUDP) and intends to apply part of the proceeds toward payments under the contract for Procurement of Hardware and System Software for Bridge Management System.

Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's [*Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers*](#) published in January 2011, revised July 2014 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

4. All interested eligible Bidders must submit an application via e-mail with contact details for their companies including contact e-mail address, to announce that they intend to participate in the bidding process and to obtain the complete set of Bidding Documents.

Bids must be submitted **only by e-mail** to the above listed e-mail addresses as well as to the additional e-mail address: pesr.bid@gmail.com; (as PDF password protected file), on or before **June 30, 2021, 11:00 CET (local time)**. Receipt of each bid will be immediately confirmed. Late Bids will be rejected. Within one hour after the Bid submission deadline Bidders must send the password of their password protected bids to all three specified e-mail addresses. Bids will be publicly open through Video Conference in the premises of the Public Enterprise for State Roads, Street "Dame Gruev", No. 14, 1000 Skopje, in the presence of the Bidders' designated representatives and anyone who chooses to follow the bids opening only by video link. Bid opening will start one hour after the

bid submission deadline. Minutes of Bid opening shall be shared with all bidders by email. Detailed instructions for submission of Bids are presented in the Bidding Documents.

7. All bids must be accompanied by a Bid Security of 3,100.00 EUR or 192,000.00 MKD.
