Bids submitted should be complete. Partial or incomplete bids will be rejected. Bidders wishing to offer discounts will be allowed to do so, provided that the discounts are included in the form of Contractor's Letter of Bid or submitted in writing (ITB 24) before the deadline for bid submission. All offers for discounts should be for the entire bid. All bids and offers for discounts shall be opened in accordance with the procedures described in the ITB and evaluated simultaneously so as to determine the lowest evaluated bid (including discounts) for the Employer. The contract will be awarded to the lowest evaluated qualified bidder. Bidders should meet all qualification criteria.

As a minimum, any Bidder has to fulfill at least the following key qualification requirements:

Eligibility: The Bidders have to satisfy the eligibility requirements (eligible countries, conflict of interest, ineligibility of the World Bank, resolutions of the United Nations Security Council, etc) according to the Bidding documents.

Financial situation: Minimum average annual construction turnover of:
