INVITATION FOR PREQUALIFICATION A3 Expressway Stip - Kocani

A. Construction works on section Stip – Krupiste (km 0+000 to km 14+300) and B. 5-year road maintenance services on section Stip – Kocani (km 0+000 to km 28+055)

This Invitation for Prequalification follows the General Procurement Notice for this project which was published on the EBRD website, *Project Procurement Notices* (<http://www.ebrd.com/pages/workingwithus/procurement/project.shtml>) on **16.02.2015**.

Public Enterprise for State Roads (PESR), hereinafter referred to as “the Client”, intends using part of the proceeds of a loan from the European Bank for Reconstruction and Development, hereinafter referred to as “the Bank”, towards the cost of **National Roads Programme**

The Client intends prequalifying firms and consortia to tender for the following contract, hereinafter referred to as “the Contract”, to be funded from part of the proceeds of the loan:

- A3 Expressway, section Stip - Kocani (km 0+000-km 14+300), for a total length of 14.300 km is part of the East-West corridor from Trebenista (connection to the A2) to the border with Bulgaria. This Contract comprises construction of the road to provide one carriageway expressway, including two 3.50 m wide traffic lanes and two 2.2 m wide hard shoulders each carriageway and maintenance service for 5 years period on section from km 0+000 to km 28+055. Basic preliminary quantities are: excavation 950,000 m³, embankments 700,000 m³, asphalt carriageway 165,000 m², 2 overpasses and 3 underpasses. Proposed period of construction is 24 months.

Prequalification and tendering for contracts to be financed with the proceeds of a loan from the Bank is open to firms and joint ventures of firms from any country.
