Contract Title: Procurement, Installation and Maintenance of Traffic Counters

1. The Public Enterprise for State Roads (PESR) has received financing from the World Bank toward the cost of the National and Regional Roads Rehabilitation Project, and intends to apply part of the proceeds toward payments under the contract for Procurement, Installation and Maintenance of Traffic Counters.
2. The Public Enterprise for State Roads now invites sealed bids from eligible bidders for procuring the traffic counters and services for:
 - delivery and installation of permanent automatic traffic counters (PAC) on 70 road sections (sites) on the state road network in 24 months,
 - 3 years traffic information collection,
 - 3 years maintenance of the system,
 - delivery of 10 mobile automatic traffic counters (MAC) and the services for the training of Client's team for installation, data collection, traffic analyses and maintenance of the devices.

In the third year of the contract the Client reserves the right to successively order more PAC depending on the needs and financial capabilities. The Client will conclude an annex for

additional PAC. The Contractor must be prepared to deliver additional PAC upon the Client's request within 20 days and install up to 10 new PAC within 60 days.

3. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers* edited January 2011 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

4. Interested eligible bidders may obtain further information from Public Enterprise for State Roads and inspect the bidding documents during office hours 09:00 to 16:00 at the address given below.
