**UPDATED GENERAL PROCUREMENT NOTICE**

Public Enterprise for State Roads ("PESR") has been using the proceeds of a loan from the European Bank for Reconstruction and Development [the Bank] for a project to finance the construction or reconstruction or rehabilitation of national and regional road sections in the Republic of North Macedonia. The project, which has a total estimated cost of EUR 181 million, has been provided in two tranches of up to EUR 95 million and up to EUR 86 million respectively, with each tranche financing the following road components:

- Under Tranche 1 – Works Contract for construction of expressway sections: Raec – Drenovo and Stip - Kocani
- Under Tranche 2 – Works related to investment programme for the rehabilitation of national and regional roads

Tendering for the above contracts funded under Tranches is ongoing. Some of the Supervision Contracts have been already awarded and those related to the forthcoming works contracts are under procurement procedure according to the National rules and procedures.

Contracts to be financed with the proceeds of a loan from the Bank have been and will be subject to the Bank's *Procurement Policies and Rules* and will be open to firms from any country. The proceeds of the Bank's loan will not be used for the purpose of any payment to persons or entities, of for any import of goods, if such payment or import is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations or under a law of official regulation of the Purchaser's country.
